Meeting of the Board of Directors



On December 1st, 2016, the PrairieStar Metropolitan District's No. 1 & 2 held a Special Meeting at the Berthoud Community Center at 6pm. At this meeting, the Board approved revisions to the PrairieStar Filing #1 & #3 Rules and Design Guidelines, approved a Service Agreement with a new trash & recycling provider, appointed a Community Liaison, and approved the creation of a District website, among other important District matters.

Changes to Rules & Design Guidelines

In order to accommodate feedback and concerns from the community, and to stay consistent with the Covenants, Conditions, and Restrictions of PrairieStar, the Board of Directors determined several revisions to the Rules and Design Guidelines were required.

At the end of December, a letter explaining these changes and other provisions, as well as a new hard copy of the Rules and Design Guidelines were sent to all homeowners. Please note this revision of the Rules and Design Guidelines, dated December 1st, 2016, replaces all previous versions.

The Rules and Design Guidelines are meant to grow and change along with the community, and will continue to evolve as PrairieStar develops.

New Trash & Recycling Service



In October of 2016, the PrairieStar Board of Directors decided to engage in a contract agreement with one, sole provider of trash and recycling services for the entire community. In order to ensure the best possible provider was contracted, the Board requested and reviewed proposals from various vendors in the Berthoud area. As a result of this due-diligence process, it has been determined that the best provider in both price and level of service is United Waste Systems, a local, small business based out of Berthoud. Another important factor in this decision is that United Waste, unlike the other providers, can provide weekly recycling for those who wish to utilize this service.

As of April 1st, 2017, the District will enter into a formal Service Agreement with United Waste Systems. Provided services, as well as costs, are listed below. (Please note, it is the responsibly of each, individual homeowner to cancel services with their current provider, and to set-up an account with United Waste Systems before April 1st, 2017); the District will work with United Waste Systems to make the service transition as smooth as possible, including a potential mass drop-off date for containers:

- Each homeowner will be billed quarterly (3 months at a time, beforehand) by United Waste Systems through their own, individual account.
 - All matters related to payment of bills, as well as all services provided, will be between United Waste Systems and the homeowner.
- Bills can be paid via automatic credit card debit, over the phone, or by a mail-in check.
- Bills must be paid within 30 days of receiving an invoice; payments after this date will incur a \$20 late fee.
- Each resident will receive a 96-gallon trash container for a fee of \$16 per month.
- Each resident who requests recycling will receive a choice in container size:
 - 26-gallon containers are an additional \$3 per month
 - o 65-gallon containers are an additional \$5 per month
- Pick-up schedule for trash and recycling will be every Tuesday (containers must be out for pick-up by 6am)
