



Board Meeting Minutes

June 5, 2017

I. Roll Call/Called to Order

The regular meeting of the Board of Directors for the Coal Creek Village Master Association was called to order at 6:20 at the East Simpson Street Coffee Company located at 414 E Simpson St, Lafayette, CO 80026. Quorum was established with the following Board member present: Shelley Thomas, Nancy Vaughn, Dennis Hanke, Dan Benjamin, Rosemary Frid and Leigh-Ann Zaharevich. Dudley Kirkpatrick was absent.

II. Homeowner Open Forum

Homeowners asked about weeds in the community and rule enforcement relating to trash cans.

III. Minutes Approval

The Board reviewed the minutes from the March 6, 2017 Board meeting. There was one correction. Mr. Hanke made a motion, seconded by Mr. Benjamin, to approve the minutes as amended. Motion passed unanimously.

IV. Financial Report

There were no questions regarding the financial report.

V. Management Report

The Community Manager gave an update on the status of the Association.

VI. Association Business

- a. Board Terms- Ms. Zaharevich & Ms. Frid were appointed to the Board earlier in 2017 but terms had not been established. Mr. Hanke made a motion, seconded by Ms. Thomas, to have Ms. Zaharevich have the 1-year term (expiring December 2017) and Ms. Frid have the 2-year term (expiring December 2018). Motion passed unanimously.
- b. Rule Amendment- The Board discussed the best way to get community feedback regarding updating the rules & regulations. The Community Manager will be sending an e-mail blast with a survey for homeowners to complete.
- c. Fine Waive- The Board agreed to waive a \$50 fine as the violation has been corrected.
- d. Pet Station-The Board discussed the request from a homeowner to install additional pet stations. They stated it's not necessary in the location specified as there are two stations a block away.
- e. Electric Repairs- Tabled
- f. Board Tasks- The Board discussed the best way to track items the Board is working on. A tab will be added to the weekly action item list the Community Manager sends out.
- g. Landscape Maintenance Policy- Mr. Hanke made a motion, seconded by Ms. Thomas, to approve the landscape policy as drafted by the attorney. Motion passed unanimously.
- h. Homeowner Request- The Board reviewed a request from a homeowner in the Attached Homes to install a fence to prevent damage to his property. The Community Manager will investigate where the irrigation lines are and ask the Attached Association Board for their input.
- i. Budget Update- The Board reviewed recommended changes to the Association's spending to incorporate the full cost of the water bills.
- j. Ratify Irrigation Repairs- Mr. Hanke made a motion, seconded by Ms. Thomas, to ratify the decision made between meetings to authorize required irrigation repairs. Motion passed unanimously.



- k. Trees & Landscaping- Mr. Hanke will be convening a Landscape Committee to review landscaping & tree needs in the community.
